



# States are projected to see varying changes in enrollment (2022 to 2031)









## **Idaho Schools Operate on Lean Margins**



# Public Charter Schools in Idaho (The struggle for operational freedoms and fair funding)

The Idaho Legislature & Governor have been a **strong supporter** of Charter Schools and have worked over the last decade to create more flexibilities for schools and to help with facility financing. This includes legislation that:

- (2012) removed the growth cap of six new public charter schools per year and the cap of one new, public charter school per district per year. Also created a per pupil facility allowance, charter schools received \$398 per student in FY 2022.
- (2016) allowed public charter schools to sign administrators and teachers to one-year contracts.
- (2017) streamlined the charter petition (approval) process, particularly for replicating schools.
- (2019) created a charter school administrator certificate as an alternative to traditional administrator certificates.
- (2019) created public charter school facilities program, which requires charters to receive approval from the Idaho
  Housing and Finance Association for issuance of nonprofit facility bonds.
- (2020) created a weighted student lottery system for schools targeting needier students.
- (2022) allowed public charter schools to hire individuals with a Bachelor's Degree and develop and certificate their own teachers without going through the cumbersome and costly traditional teacher certification process.
- (2023) created a \$50 million revolving loan fund for public charter schools.
- (2024) rewrite of Idaho's Public Charter School law "Accelerating Public Charter Schools Act"

# **Bluum Successfully Closed Out Our First Federal Charter School Program Grant**

**Context:** We were the second nonprofit in America to receive a State Entity federal CSP grant, and the first to successfully complete and close out the grant.

**Anser Public Charter School in Action** 



Bluum was awarded \$24,870,000 in competitive CSP Grant Support. Our plan has three primary objectives:

- 1) Increase the number of quality Idaho charter school seats by no less than 5,900 students, especially for our most educationally disadvantaged and rural students through start-up, replication or expansion;
- 2) Support quality authorizing in Idaho while disseminating and supporting best authorizer practices statewide; and
- 3) Evaluate and disseminate widely the successes and lessons of high-quality charter schools to impact the broader education system.

We expect to issue 10 grants of \$2 million each, and 3 to 5 smaller grants of up to \$800,000 each. All of this work is done in consultation and alignment with **JKAF**.

Through a competitive bidding process, we selected **The National Charter Schools Institute** to work with Bluum, the Idaho Public Charter School Commission (IPCSC), and other Idaho-based authorizers to conduct technical assistance activities that support improving Idaho's charter school authorizing efforts. We can allocate up to \$750,000 in support over the next four years, if it adds value!

**The one-year contract is for \$198,000.** Contract is available for those who want to read it.

We write in support for the Federal Charter School Program (CSP) Grant Funding application submitted by Bluum. We have long supported the growth of strong schools in our state and are proud to support the work represented by Bluum's *Building on Success for Future Excellence* CSP proposal.

Idaho is one of the fastest growing states in the nation, which has presented both challenges and opportunities in education. In recent years, the public and private sectors have come together to ensure students of all backgrounds in even our most rural communities have access to high-quality education. We are told that Bluum's proposal builds on the momentum of Idaho's 2018 *Communities of Excellence* CSP grant award (2018-23). With Bluum's help, Idaho's public charter school sector has been one of the nation's fastest growing and highest achieving over the last five years, having grown from 52 schools serving 22,000 students to 70 schools serving over 30,000 students. During this period, the Bluum-managed *Communities of Excellence* CSP Grant funded growth at 28 charter schools with an expected 11,467 seats to be created. Further, many of the state's highest performing public schools on state ISAT achievement tests in both English Language Arts and mathematics are perennially charter schools. The same holds for the SAT.

Bluum's *Building on Success for Future Excellence* CSP proposal expands on this innovative work by: 1) increasing the number of quality Idaho charter school seats by no less than 5,900 students, especially for our most educationally disadvantaged and rural students through start-up, replication, and expansion; 2) supporting quality authorizing in Idaho while disseminating and supporting best authorizer practices statewide; and 3) evaluating and sharing the successes and lessons of high-quality charter schools to impact the broader education system. The CSP support requested in this proposal will expand the educational opportunities available to students and families across the great state of Idaho, while also fostering the ongoing development of strong charter authorizers like the Idaho Public Charter School Commission.

Bluum will continue its collaboration with key state partners. Bluum's partners are numerous and come from both the public and the nonprofit sectors. The most important are the Idaho State Board of Education, the Idaho Public Charter School Commission, the J.A. and Kathryn Albertson Family Foundation, the non-profit school facilities finance group Building Hope, the Idaho Charter School Network, and individual charter school operators and governing boards.

We urge the Department of Education to give this grant application all due consideration.

# What Subgrantee Schools Can Use the Money For

#### Allowable expenses include one or more of the following:

- (a) Preparing teachers, school leaders, and specialized instructional support personnel, including through paying costs associated with
  - (i) Providing professional development; and
  - (ii) Hiring and compensating, during the eligible applicant's planning period specified in the application for funds, one or more of the following: (A) Teachers. (B) School Leaders. (C) Specialized instructional support personnel.
- (b) Acquiring supplies, training, equipment (including technology), and educational materials (including developing and acquiring instructional materials).
- (c) Carrying out necessary renovations to ensure that a new school building complies with applicable statutes and regulations, and minor facilities repairs (excluding construction).
- (d) Providing one-time startup costs associated with providing transportation to students to and from the charter school.
- (e) Carrying out community engagement activities, which may include paying the cost of student and staff recruitment.
- (f) Providing for other appropriate, non-sustained costs related to opening, replicating, or expanding high-quality charter schools when such costs cannot be met from other sources.

#### 1) Predevelopment:

- Architect, design, due diligence, etc.
- Riskiest part of the process but lowest costs, usually \$350K-\$700K for 6 months to 2 years. Our \$3.5 million CSP Credit Enhance Grant helps greatly.

### 2) Build and Launch

- Primarily led by Building Hope with JKAF support
- 20 plus deals so far with refi happening after 3, 4 or 5 years
- Usually, 30-35% PRI and 65-70% primary lender

### 3) Long-Term Financing

- The goal of 1 and 2 is to enter 3 in as strong of a position as possible because these deals are 30-35 years on the full loan amount.
- Up to now this has primarily been through tax-exempt bonds issued by IHFA. This has been facilitated by the moral obligation law.
- This stage is critical to the long-term health of schools.

### **IDAHO CREDO RESULTS 2023**

Margaret Raymond and James Lynn Woodworth, from Stanford's Center for Research on Education Outcomes (CREDO), presented new information in February 2023 on Idaho's charters that was collected from 2014 to 2018. It has also been studying charter schools in 29 other states, and said CREDO is known nationally as the "charter school analysis people."

Idaho's special education students are doing notably well in charter schools.

"Idaho's special education results are among the best that we've seen nationally," Raymond said. "We normally see a much larger offset of learning in the special education community."

Similarly, Idaho's students in poverty are doing as well at charter schools as they are in traditional schools, which is rare.

"There is an overall best practices emerging from the picture that we see over time in Idaho that we think actually could be important for other charter school communities around the country to look at, particularly in poverty and (special education)," Raymond said.









#### **Bluum and Other States**

- In the last six months staff at Bluum have had conversations with other charter school support groups and state agencies in Arkansas, Mississippi, Alabama, Washington, Nevada, Utah, Arkansas, Oklahoma, Pennsylvania, Connecticut, West Virginia, Missouri and Maryland. Most of these conversations are around federal Charter School Program grant topics, issues and concerns. We share a lot of information and resources.
- More recently we have had conversations with groups in Texas, North Carolina and South Carolina
  on Idaho's Revolving Loan Fund and how it works. We also had school operators and charter
  support groups visit us from New Mexico and Mississippi. We will have a visitor over the summer
  from Tennessee.
- Closer to home, Bluum has worked closely with the state of Montana to develop their charter school program including the roles and responsibilities of the Montana Charter School Commission.
- All of our support and time is provided to these partners pro bono because JKAF funds our day-to-day operations.
